The Assignor further agrees to execute and deliver all documents, instruments, forms and authorizations, and take all other actions (including, without limitation, the registration and recording of assignments or filings with any applicable governmental agency) that may be necessary for securing, completing or vesting in the Assignee all of the Assignor's right, title, and interest in and to the Marks.
