Con la presente scrittura privata (in appresso il "Contratto"), redatta esclusivamente dalle parti, che resterà depositata nei rogiti del notaio autenticate le sottoscrizioni, e da valere ad ogni effetto di legge le parti:

nella persona del legale rappresentante pro-tempore signora:

- GASPARINI ANNA MARIA, nata ad Istrana (TV) il 18 gennaio 1952 e domiciliata per la carica presso la società come in atti costituita, nella sua qualità di Amministratore Unico;

e

- "**FAST BRANDS S.R.L.**" con unico socio, con sede legale in Silea in Via Enrico Fermi n. 2, con capitale sociale di €. 10.000 (diecimila) interamente versato, costituita in Italia ed iscritta nel Registro delle Imprese di TREVISO;

Premesso che:

A. In data 20 maggio 2014, è stata sottoscritta tra le parti una lettera di intenti con la quale le parti si impegnavano a trasferire entro il 15 giugno 2014 il portafogli marchi come meglio identificati e descritti nell'allegato "A" al presente Contratto da SIX S.R.L. a favore di FAST BRANDS S.R.L.;

C. SIX S.R.L. intende cedere a FAST BRANDS S.R.L., che a propria volta intende acquistare da SIX S.R.L. i Marchi;

Tutto ciò premesso a formare parte integrante e sostanziale del presente Contratto, anche ai fini dell'interpretazione dello stesso, le Parti convengono e stipulano quanto segue

Articolo 1

Premesse ed Allegati

1.1. Le Premesse e l'Allegato formano parte integrante e sostanziale del presente Contratto e rivestono per le Parti valore e forma di contratto, unitamente alle altre clausole del presente Contratto.

Oggetto

2. La società "**SIX S.R.L.**", come sopra rappresentata, cede e trasferisce alla società "**FAST BRANDS S.R.L.**" con unico socio che, anch'essa come sopra rappresentata acquista, i Marchi di cui all'allegato A, a fronte del pagamento del Corrispettivo come infra definito.

Articolo 3

Corrispettivo

3.1. La società FAST BRANDS S.R.L., a titolo di corrispettivo per il trasferimento dei Marchi, verserà alla società SIX S.R.L. la somma pari ad Euro 1.025.000,00 (unmilioneventicinquemila) oltre I.V.A. a norma di legge (in appresso il "Corrispettivo").

3.2. Il Corrispettivo sarà versato - con modalità tracciabili - entro il 16 (sedici) giugno 2014 (duemilaquattordici); infruttifero di interessi.

La parte venditrice viene esonerata dall'onere della formale richiesta di adempimento nei confronti della parte acquirente.

Il pagamento verrà effettuato mediante bonifico bancario sul c.c. della società SIX S.R.L. intrattenuto presso la filiale di Treviso dell'Istituto Unicredit Banca.

Articolo 4

Dichiarazioni e Garanzie

4.1. SIX dichiara e garantisce che, alla data di sottoscrizione del presente Contratto:

a) i Marchi sono di propria esclusiva proprietà, liberi da pesi e/o vincoli e/o gravami di qualsiasi natura e genere;

b) i Marchi sono validi e risultano essere stati legittimamente usati e mantenuti, in conformità alla normativa nazionale e/o internazionale e/o comunitaria rispettivamente applicabile;

c) non sussistono, né vi è motivo di ritenere che possano sussistere, cause di nullità, annullabilità, inefficacia o decadenza dei Marchi;

d) non sono stati conclusi contratti di cessione o licenza diversi da quelli individuati dalle parti in sede di sottoscrizione della lettera di intenti [licenza d'uso a favore di AXO AMERICA INC.] in forza dei quali sia stato concesso a terzi l'utilizzo, sotto qualsiasi forma, dei Marchi;

Articolo 6

Indennizzo, manleva e clausola penale

6.1. SIX si obbliga a tenere manlevata ed indenne FAST BRANDS, da qualsivoglia pretesa avanzata da terzi a titolo di risarcimento di qualsivoglia danno (comprensivo sia il danno emergente sia il lucro cessante), costo, onere, spesa (incluse le eventuali spese legali sostenute da FAST BRANDS), perdita, minusvalenza, derivante e/o originato/a, direttamente e/o indirettamente, dall'inadempimento ad alcuna delle obbligazioni assunte in forza del Contratto poste in essere da SIX e/o da terzi a cui quest'ultima abbia attribuito, espressamente e/o tacitamente, la facoltà di utilizzare i Marchi.

6.2. In particolare SIX si obbliga a tenere indenne e a manlevare FAST BRANDS da qualsiasi pretesa azionata da terzi in relazione alla gestione e/o utilizzazione e/o sfruttamento dei Marchi.

6.3. Salvo il diritto al risarcimento del maggior danno subito, e salvo quanto previsto innanzi, ove SIX si renda inadempiente alle obbligazioni assunte o nel caso in cui le dichiarazioni e garanzie rese ai sensi del precedente articolo 4 non rispondano al vero, anche ove l'inadempimento, o la mancata rispondenza al vero, derivi da atto e/o fatto imputabile a terzi, SIX sarà obbligata a corrispondere a FAST BRANDS a titolo di penale, entro 30 giorni liberi dal ricevimento della relativa richiesta scritta, un importo pari ad Euro 30.000,00 (trentamila).

Articolo 8

Pubblicità

8.1. FAST BRANDS avrà la facoltà di pubblicizzare i propri prodotti, contraddistinti dai Marchi, con qualsiasi mezzo, destinati a qualsiasi distribuzione.

Articolo 9

Nomi a dominio

9.1. Le Parti prendono atto che AXO SPORT S.p.A. ha registrato ed utilizza in via esclusiva il nome a dominio composto dal Second Level Domain "AXOSPORT" e/o "AXO", accompagnato dai Country code Top Level Domain designanti Paesi quali l'Italia (.it) nonché designanti Paesi diversi dall'Italia nonché dai Top Level Domain tematici.

9.2. Le Parti convengono pertanto che a FAST BRANDS S.R.L. sarà attribuita la facoltà di registrare ed utilizzare in via esclusiva il Domain name composto dal Second Level Domain "AXO" e/o "AXOSPORT", accompagnato dai Country code Top Level Domain ritenuti necessari all'espletamento delle proprie funzioni aziendali subentrando nella titolarità dei nomi a dominio attualmente intestati a AXO SPORT

aventi ad oggetto il Second Level Domain "AXO" e "AXOSPORT".

9.3. Resta peraltro inteso che a FAST BRANDS S.R.L. viene attribuita la facoltà - ove dovesse risultare interessata e nel caso in futuro divengano registrabili - di procedere alla registrazione a proprio nome in via esclusiva dei nomi a dominio con Top Level Domain tematici diversi e nuovi rispetto agli attuali.

Articolo 10

Miscellanea

10.1. Accordo tra le Parti

Il presente Contratto costituisce il frutto delle trattative intercorse tra le Parti e contiene tutte le pattuizioni raggiunte fra le stesse, salvo che non sia tra le stesse diversamente e specificamente pattuito per iscritto; esso sostituisce e supera ogni diversa e precedente pattuizione. Ogni modifica al presente atto andrà fatta per iscritto e dovrà essere sottoscritta dai rappresentanti di ambo le parti.

Le Parti reciprocamente riconoscono che le singole clausole del presente Contratto sono state oggetto di contrattazione tra le stesse e che pertanto non trovano applicazione le disposizioni di cui agli artt. 1341 e 1342 del codice civile.

10.2. Modifiche ed Interpretazione

AGREEMENT FOR THE SALE OF TRADEMARKS

By this private agreement (hereafter the "Agreement"), drawn up exclusively by the parties, which shall be retained by a notary public, who shall verify the signatures, and shall have all effects in law, it is hereby agreed and covenanted between the parties as follows:

- "SIX S.R.L." with registered office in VIA CASTELLANA 90, ISTRANA (TV), in the village of OSPEDALETTO, tax code and VAT Number 01879460267, share capital Euro 10,400.00, incorporated in Italy in the person of its pro tempore legal representative Sig.ra

- GASPARINI ANNA MARIA, born in Istrana (TV) on 18 January 1952 with domicile for the appointment on the premises of the company, as incorporated by deeds, in her capacity as Sole Director;

and

- "FAST BRANDS S.R.L." with sole proprietor, with registered office in Via Enrico Fermi 2, Silea, with fully paid-up share capital of 10,000 (ten thousand). incorporated in Italy and on the Companies Register of TREVISO;

Registration number and Tax Code 04668590260;

in the person of its pro tempore legal representative Sig.ra

- FRACASSO ILARIA, born in Florence (FI) on 3 May 1981, domiciled for the purpose of the appointment on the premises of the company, as incorporated by deeds, in her capacity as Sole Director;

(hereafter SIX and FAST BRANDS, jointly the "Parties" or individually the "Party")

Whereas:

A. On May 20 2014, a letter of intent was signed by the Parties by which they agreed to transfer by 15 June 2014 the portfolio of trademarks as specified in Annex A to this Agreement from SIX S.R.L. to FAST BRANDS S.R.L.;

B. SIX S.R.L. is the full owner to this date of the trademarks specified in Annex A (hereafter the "Trademarks");

C. SIX S.R.L. intends to transfer to FAST BRANDS S.R.L. which wishes to purchase from SIX S.R.L. the Trademarks;

The recitals being an integral and substantive part of this Agreement, including for the purposes of its interpretation, the Parties hereby agree and covenant as follows:

Article 1

Recitals and Annexes

1.1. The Recitals and Annex are an integral and substantive part of this Agreement and have the value and form of a Contract, together with the other articles of this Agreement.

1.2. Annex:

A) Trademarks and patents to be sold;

Article 2

Object

2. The company SIX S.R.L., as described above, shall sell and transfer to the company FAST BRANDS S.R.L. with sole proprietor, as described above, which shall purchase the Trademarks specified in Annex A, against payment of a Fee, as specified below.

Article 3

Fee

3.1. The company FAST BRANDS S.R.L. shall pay a fee for the Trademarks to SIX S.R.L. in the amount of Euro 1,025,000.00 (one million twenty-five thousand) plus VAT according to the law (hereafter the "Fee").

3.2. The Fee shall be paid - in a manner that can be traced - by 16 (sixteen) June 2014 (two thousand fourteen), without interest.

The Seller shall not be held to the formal request for performance by the Purchaser.

Payment shall be made by bank remittance to the account of SIX S.R.L. held at the Treviso branch of Unicredit Bank.

Article 4

Declarations and Warranties

4.1. SIX declares and warrants that at the date of this Agreement:

a) the Trademarks are the exclusive property, free of encumbrance and/or attachment and/or liens, of any kind or nature;

b) the Trademarks are valid and have been lawfully used and maintained, in compliance with national and/or international and/or Community law as applicable;

c) there is no cause, nor is there reason to believe there may be cause, to render the Trademarks null and void, or capable of rendering them null and void, invalid or lapsed;

d) except for those specified in the signed letter of intent (licence for the use of trademarks to AXO AMERICA INC.) no sales or licence agreements have been stipulated in relation to the trademarks which provide licencing rights to third parties, in any form;

e) no claims have been made or threatened by third parties, either in or out of Court, nor have any actions been brought or claims made about the validity and/or voidness and/or lapse and/or ineffectiveness of the Trademarks, nor is there reason to believe that any such claims will be made in the future.

4.2. The declarations and warranties set out above in paragraph 1 shall be truthful at the date of signing the Agreement and at the time the Trademarks are subsequently transferred (meaning the date on which the transfer shall

prevail over third parties following transcription in the relevant registries).

4.3. Without prejudice to any liability arising, SIX shall promptly notify FAST BRANDS of any fact and/or event and/or circumstance and/or situation of which it becomes aware (including after the signature of this Agreement) which may render such declarations and warranties untruthful or invalid or which prohibits the free disposal of the Trademarks and/or compromises their value and/or existence and/or validity.

Article 5

Performance, expenses and taxes

5.1. FAST BRANDS shall carry out all the formalities, including transcription into the relevant registries, and bear the costs (taxes and duties) arising, in compliance with national and/or international and/or Community regulations, as applicable, in order to render the transfer of the Trademarks specified in this Agreement valid and effective and to ensure it prevails over third parties.

5.2. Specifically, SIX authorizes FAST BRANDS to carry out all the actions required for the transcription of this Agreement with the

relevant Trademark Offices and shall agree to take whatever action is necessary to ensure the Trademarks are properly transferred. For this purpose, if requested by FAST BRANDS, the Parties shall sign, with the necessary formalities, any ad hoc deeds whose effect and validity shall be limited to the above-mentioned transcription, without amendment or substantive renewal of the contents of this deed.

Article 6

Indemnity, harmlessness and penalty clause

6.1. SIX shall hold FAST BRANDS harmless from any claims brought by third parties for damages of any sort (including consequential loss or damage and loss of profit), any cost, charge, expense (including legal costs incurred by FAST BRANDS), loss, capital loss arising from and/or directly and/or indirectly originating in failure to meet any of its obligations under this Agreement and binding on SIX and/or third parties to whom SIX has explicitly and/or tacitly attributed the faculty to use the Trademarks.

6.2. Specifically, SIX shall hold FAST BRANDS harmless from any claim or legal action brought by third parties in relation to the management and/or use and/or exploitation of the Trademarks.

6.3. Without prejudice to the right to sue for additional damages and to the above, where SIX fails to meet its obligations or where the declarations it makes and warranties it provides pursuant to article 4 above, prove untruthful or invalid, including cases in which this is due to the actions and/or statements of third parties, SIX shall, within 30 calendar days of receipt of the written request, pay FAST BRANDS a penalty of Euro 30,000.00 (thirty thousand).

Article 7

Company names

7.1. FAST BRANDS declares and acknowledges that the transfer of the Trademarks shall not attribute to FAST BRANDS or its assignees until January 1 2015 any rights on the company name AXO SPORT S.p.A. and hence the rights and faculties attributed to AXO SPORT UNDER Article 9.1. below shall remain with the company even after signature of this Agreement and until the time and under the terms specified herein.

Article 8

Advertising

8.1. FAST BRANDS may advertise its products, carrying the Trademarks, by any means it sees fit and for any distribution system.

Article 9

Domain names

9.1. The Parties acknowledge that AXO SPORTS S.p.A. has registered and uses on an exclusive basis the domain name comprising the Second Level Domain "AXOSPORT" and/or "AXO", accompanied by the country code Top Level Domain identifying countries such as Italy (.it) and countries other than Italy and thematic Top Level Domains.

9.2. The Parties therefore agree that FAST BRANDS S.R.L. shall have the faculty to register and use on an exclusive basis the Domain name comprising the Second Level Domain "AXO" and/or "AXOSPORT", accompanied by the Country code Top Level Domains considered necessary to carry out their company functions, taking over the rights to the domain names currently held by AXO SPORT in relation to the Second Level Domains "AXO" and "AXOSPORT".

9.3. In addition, FAST BRANDS S.R.L. shall have the faculty - where it shows interest and where registration becomes possible in the future - to register under its name and on an exclusive basis domain names with thematic Top Level Domains other than those that currently exist.

Article 10

Miscellaneous

10.1. Agreement between the Parties

This Agreement is the result of negotiations between the Parties and includes all the agreements reached between them, unless otherwise agreed in writing by the same Parties; it replaces and supersedes all previous agreements. Any amendment to this deed shall be agreed in writing by representatives of the Parties.

The Parties acknowledge that the individual articles of the Agreement have been negotiated by them and hence the measures enshrined in sections 1341 and 1342 of the Italian Civil Code are not applicable.

10.2. Amendments and Interpretation

Any exception or amendment to the Agreement shall be valid and take effect only if in writing and signed by both Parties.

The Agreement shall be interpreted and carried out in good faith, in light of the common intentions of the Parties and the substantive result which, by means of the Agreement, the Parties wish to achieve.

10.3. Continuing validity

Should any single provision of the Agreement be or become invalid or without effect, based on the law or provisions of the public authorities, the validity and effect of the remaining provisions shall not be compromised, unless the Agreement proves unable, as a result of the invalidity and lack of effect of the provision, to achieve the intended result.

Without prejudice to the above, should for any reason any provision of the Agreement become invalid or lose its effect, or be declared invalid or without effect by a public authority, on the basis of the law applicable in the territory, the Parties shall replace provisions that are not valid or have no effect with other provisions with, insofar as it is possible, the same purpose as the provisions that are not valid or are without effect, in compliance with the law.

10.4. Waivers

Should either Party tolerate behaviour that may be construed a failure by the other to meet its obligations under the Agreement, the Party shall not be deemed to have waived its rights under the provisions of the Agreement that have not been complied with and may enforce the Agreement in full.

10.5. Notices

All notices and communications between the Parties scheduled or required under this Agreement, or which become necessary in relation to it, shall be in writing and handed over in person or by registered letter with notification of receipt, sent to the following addresses (or others as specified at a later date in writing):

(I) for "SIX S.R.L." at its registered office in VIA CASTELLANA 90, ISTRANA (TV), in the village of OSPEDALETTO;

(II) FOR "FAST BRANDS S.R.L. at its registered office in Via Enrico Fermi 2, Silea.

All notices shall be deemed delivered as follows: (I) if handed over in person, on the date of the handover, which shall be proven by a signed and dated receipt; (II) if sent by registered letter, on the date of the notification of the receipt or confirmation.

10.6. Applicable Law and Law Court

Any dispute arising in relation to the interpretation, execution, termination or advance termination of the Agreement shall be settled exclusively by the Venice Court, excluding any other competing or alternative Court.

This Agreement is governed by, and shall be interpreted according to, Italian law.
