Ladies and Gentlemen:

Reference is made to that Note and Warrant Purchase Agreement, dated as of September 30, 2011 (as the same may from time to time be amended, restated, supplemented or otherwise modified from time to time, the "Note Purchase Agreement"), by and among Lucky Strike Entertainment, L.L.C., a Delaware limited liability company (the "Borrower"), Lucky Strike Entertainment, Inc., a California corporation ("Holdings"), each direct or indirect subsidiary of Holdings (other than Borrower) from time to time party thereto (together with Borrower and Holdings, collectively, the "Borrower Group"), and Endeavour Structured Equity and Mezzanine Fund I, L.P. ("Purchaser"). Capitalized terms not otherwise defined herein shall have the meanings set forth in the Note Purchase Agreement.

Purchaser has been advised by the Borrower Group that the Senior Secured Lenders have agreed to amend the Senior Secured Credit Facility to increase the amount of Senior Secured Debt, subject to certain conditions precedent, including the condition that the Borrower Group retire all of their indebtedness owed to Purchaser under the Note Purchase Agreement and the other Purchase Documents (the "Indebtedness"). The outstanding principal and accrued PIK Interest, prepayment fee (pursuant to Section 3.3 of the Note Purchase Agreement) and other fees, expenses and amounts constituting Indebtedness are set forth on Exhibit A attached hereto.

The aggregate amount of the Indebtedness, if paid prior to 12:00 p.m. Portland time on December 20, 2013, will be \$[REDACTED], which amount includes all outstanding principal of loans and advances, interest, fees, costs and expenses as of such date due with respect to the outstanding Indebtedness. Thereafter, interest shall continue to accrue daily in the amount of \$[REDACTED] per day until paid in full (the amounts specified in this paragraph in the aggregate referred to herein as the "Outstanding Amount"). Payment of the Outstanding Amount shall be made by wire transfer as follows:

In consideration of the payment to Purchaser of the Outstanding Amount, Purchaser hereby (i) acknowledges and agrees that payment of the Outstanding Amount will constitute payment in full of all of the Indebtedness and other obligations (other than contingent indemnity obligations for which no claim has been asserted) owing by Borrower Group to

Purchaser; (ii) represents that Purchaser has no other credit arrangements with, loans outstanding to, guaranties by, or interests or liens against the Borrower Group or their respective properties except for those which shall be satisfied and discharged by the payment of the Outstanding Amount; (iii) agrees that it will immediately cause its counsel, Morrison & Foerster LLP, to return the SEAM Senior Subordinated Note, in the original principal amount of \$[REDACTED], to Borrower, and (iv) the Note Purchase Agreement, the SEAM Senior Subordinated Notes, the Pledge Agreement (Troy), the other Purchase Documents, including those certain Warrants dated as of September 30, 2011 evidencing the right of Purchaser to purchase membership interest of the Borrower, shall be terminated and of no further force or effect.

Purchaser agrees that, upon receipt by Purchaser of the Outstanding Amount, Purchaser shall procure, deliver or execute and deliver to the Borrower Group, from time to time, all further releases, termination statements (including those pertaining to Kevin Troy), certificates, instruments and documents, each in form and substance reasonably satisfactory to the Borrower Group, and take any other actions, as may be reasonably requested by the Borrower Group or which are required to evidence the consummation of the payoff contemplated hereby, in each case at the expense of the Borrower Group (including attorneys' fees and expenses).


Purchaser further agrees that, upon receipt by Purchaser of the Outstanding Amount, Purchaser hereby authorizes the Borrower Group, or any other party on behalf of the Borrower Group, to prepare and file termination statements, intellectual property releases and other instruments and documents evidencing the consummation of the payoff contemplated hereby and the aforementioned termination and release.

This letter may be executed in multiple counterparts and by facsimile signature, each of which shall be deemed an original and all of which together shall constitute one instrument.
