RELEASE OF TRADEMARK SECURITY AGREEMENT

October 14, 2016

WHEREAS, pursuant to that certain SECOND LIEN TRADEMARK SECURITY AGREEMENT, dated as of August 11, 2009 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 004042, Frame 0237 on August 11, 2009, REVERE PLASTICS SYSTEMS, LLC, a Delaware limited liability company ("Releasee"), granted, to CANADIAN IMPERIAL BANK OF COMMERCE, a Canadian banking institution ("Releasor"), as administrative agent, for the benefit of the Secured Parties, a continuing security interest in all right, title and interest of Releasee in, to and under the trademarks and service marks listed on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks"), together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Trademark Collateral"), to secure the payment, performance and observance of the Secured Obligations; and

WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Releasor hereby, without any representation and warranty and without any recourse to Releasor, releases, relinquishes and discharges its continuing security interest in the Trademark Collateral.
