Ladies and Gentlemen:

This letter confirms that, upon receipt by Southport Lanes, Incorporated d/b/a Spare Time Entertainment Incorporated ("Southport") of a wire transfer in the aggregate amount of \$ [REDACTED] (the "Payoff Amount"), the payment obligations owed by Lucky Strike Hollywood, Inc. (together with its affiliates "Lucky Strike") to Southport under Section 3(c) of that certain Agreement for Purchase and Sale of Marks, dated as of May 27, 2005, by and between Southport and Lucky Strike, will be paid in full and all security interests and liens held by Southport on the assets of Lucky Strike, including under that certain Trademark Security Agreement, dated as of May 27, 2005, between Southport and Lucky Strike, will be terminated and released, without the necessity of any further action by Southport or Lucky Strike. To avoid any doubt, the remaining payment provisions of Section 3, including but not limited to (d) and (e), remain in full effect regardless of this letter.

Effective upon receipt by Southport of the Payoff Amount, (a) Southport authorizes Lucky Strike or its agent to prepare and file any and all documents and instruments, including UCC termination statements, reasonably necessary or required to discharge any and all security registrations previously filed by Southport against the assets of Lucky Strike, and (b) Southport shall execute and deliver to Lucky Strike any lien releases, discharges of security interests, and other similar discharge or release documents as are necessary to effectuate the termination and release of the security interests and liens against the assets of Lucky Strike.
