TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of 9-12, 2016, by WELLS FARGO BANK, NATIONAL ASSOCIATION (successor by merger to Wachovia Bank, National Association, successor by merger to Congress Financial Corporation) and WELLS FARGO CAPITAL FINANCE CORPORATION CANADA (successor to Wachovia Capital Finance Corporation (Canada), successor to Congress Financial Corporation (Canada)), (individually the "Secured Party" and collectively the "Secured Parties").
