ACKNOWLEDGMENT OF TERMINATION OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Acknowledgment of Termination of Intellectual Property Security Agreement (this "Release") is conveyed as of October 19, 2016, by Pacific Western Bank (as successor in interest by merger to Square 1 Bank), as Bank under the Intellectual Property Security Agreement referred to below (in such capacity, "Bank"), in favor of Piracle, Inc., a Utah corporation (the "Grantor").

WHEREAS, reference is made to that certain Intellectual Property Security Agreement dated January 8, 2015 (as amended, amended and restated, supplemented, or otherwise modified prior to the date hereof, the "IP Agreement"), by and between the Grantor and Bank.

WHEREAS, the IP Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on October 6, 2015, at Reel 005639 Frame 0127, with respect to the trademarks set forth on Exhibit A hereto (the "Trademarks").

WHEREAS, Bank wishes to terminate the IP Agreement and release, retransfer and reassign to the Grantor, without representation or warranty, all of Bank's right, title and interest in and to the Trademarks and the goodwill associated therewith, and the copyrights set forth on Exhibit B hereto (the "Copyrights").

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Bank hereby terminates the IP Agreement and the security interest granted therein, and releases, retransfers and reassigns to the Grantor, without representation or warranty, all of Bank's right, title and interest in and to the Grantor's Intellectual Property Collateral (as defined in the IP Agreement) (including, without limitation, the Trademarks and the goodwill associated therewith, and the Copyrights). Bank does hereby further authorize and consent that this Release may be recorded and indexed by the USPTO and the United States Copyright Office.


