TRADEMARK ASSIGNMENT

This Trademark Assignment Agreement ("this Agreement") is entered into as of August 24, 2015 by and between TEDESCHI FOOD SHOPS, INC., a Massachusetts corporation ("Assignor") and TFS NEWCO LLC, a Delaware limited liability company ("Assignee").

WHEREAS, pursuant to the Intellectual Property Assignment Agreement between the parties on August 24, 2015 and the related Contribution, Purchase and Sale Agreement between Assignor, Assignor's affiliates and 7-Eleven, Inc. on May 15, 2015, Assignor agreed to assign to Assignee all of the Assignor's right, title and interest in and to certain trademarks, including, without limitation, the U.S. trademark registrations set forth on the attached Schedule A (collectively the "Assigned Marks"); and

WHEREAS, Assignee wishes to acquire all right, title and interest in and to the Assigned Marks, including the registrations therefor and the goodwill symbolized thereby.

NOW, THEREFORE, for good and valuable consideration, receipt for which is hereby acknowledged, the parties hereto agree as follows:

Assignor irrevocably sells, assigns, conveys and transfers to Assignee, its successors, and assigns, absolutely and forever, all right, title and interest, whether statutory or at common law, Assignor now has or ever has had in and to each of the Assigned Marks, together with any trademark registrations therefor, together with the goodwill associated with the business symbolized by said Assigned Marks and all rights now and hereinafter existing or arising out of or relating to the use or ownership of said Assigned Marks, including all rights to sue for past infringement and all rights to receive and retain the proceeds relating to those past infringements, as well as of Assignor's other rights and interest in the Assigned Marks, including all common law rights therein.

Assignor agrees that Assignee may singularly, and without assistance or consent from Assignor, undertake procedures to record the transfer of the Assigned Marks to Assignee in the United States Patent and Trademark Office.



