## TRADEMARK ASSIGNMENT AGREEMENT

**THIS TRADEMARK ASSIGNMENT AGREEMENT** (this "Agreement"), dated effective as of September 1, 2016, is by and among Englander Sleep Products, L.L.C., a Delaware limited liability company ("Seller"), and, Eastern Sleep Products Co., Inc., a Virginia corporation ("Buyer") (each a "Party" and collectively, the "Parties").

### WITNESSETH:

**WHEREAS**, Seller is the owner of the trademark DREAM KING, used in association with the sale of mattresses and box springs, and considering Sellers desire to transfer and assign all right title and interest in the trademark to Buyer;

**NOW, THEREFORE**, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

1. Seller hereby sells, conveys, transfers and assigns to, and vests in, Buyer, its successors and assigns forever, all of Seller' right, title and interest, legal or equitable, in and to the trademark DREAM KING for use with mattresses (the "Mark"), and all goodwill associated therewith. Such conveyance, transfer, assignment, and vesting shall be effective as of 12:01 A.M. on September 1, 2016.

2. Transfer of the Mark includes all right, title and interest in the federal trademark registration before the United States Patent and Trademark Office, Registration Number 0374725.

3. The Mark is transferred by Seller without any warranty whatsoever, including any warranty as to the validity or enforceability of the Mark, or of United States Patent and Trademark Office Registration Number 0374725.

4. Transfer of the Mark includes any and all litigious rights related to or arising out of the Mark, including, but not limited to, all rights by Seller to sue for infringement, damages, and declaratory and injunctive relief, regardless of whether such rights arise from conduct occurring before or after the effective date hereof.

5. At any time and from time to time after the date hereof, the Parties shall execute and deliver, or shall cause to be executed and delivered, to the other Party such other instruments and take such other action as may be reasonably requested to carry out the intent and purposes of this Agreement.


6. This Agreement and the covenants and agreements herein contained shall survive the date hereof and shall inure to the benefit of the Parties and their respective successors and assigns, and shall be binding upon the Parties and their respective successors and assigns.

7. This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, and such counterparts shall constitute but one and the same instrument.



Each party represents and warrants to the other party as follows: (i) it is an entity duly organized, validly existing and in good standing under the laws of its State of formation; (ii) it has all requisite corporate power and authority to execute and deliver this Agreement and perform all of its obligations hereunder; (iii) it has taken all corporate action necessary for the authorization of this Agreement and the performance of all of its obligations hereunder; and (iv) this Agreement, when executed and delivered by the parties hereto, will be its valid and binding obligation enforceable against it in accordance with the terms hereof, except (a) as limited by applicable bankruptcy, insolvency, reorganization, moratorium or other laws of general application affecting enforcement of creditors' rights, and (b) general principles of equity.
