RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of October 6, 2016 by BFI BUSINESS FINANCE, a California corporation, ("Secured Party"). Capitalized terms used but not defined herein will have the meaning given to them in the Intellectual Property Security Agreements (hereinafter defined).

WHEREAS, Secured Party is a party to (i) the Intellectual Property Security Agreement dated as of October 29, 2012 by and between Artistica, a California corporation formerly known as Artistica Metal Designs, Inc., and Secured Party, and (ii) the Intellectual Property Security Agreement, Amended and Restated, dated as of April 1, 2015 by and between Artistica, LLC, a California limited liability company as successor in interest to Artistica, a California corporation, and CapitalSource Business Finance Group, a dba of Secured Party (together the "Intellectual Property Security Agreements"); and

WHEREAS, Secured Party has agreed to release its entire rights and security interests in the Intellectual Property Collateral granted under the Intellectual Property Security Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby (i) fully and finally releases and terminates its security interest in, liens on, and all other rights in, to and under the Intellectual Property Collateral, including but not limited to the liens and security interests in the intellectual property rights listed on Schedule I hereto, and all products and proceeds of the foregoing, and to any other rights it might have relating to the intellectual property arising under the Intellectual Property Security Agreements (provided, however, that nothing contained herein shall limit Secured Party's rights with respect to any of its other collateral including, but not limited to, accounts receivable and rights to payment that may arise from use of the Intellectual Property Collateral, and inventory that may utilize the Intellectual Property Collateral), and (ii) authorizes the filing of UCC Financing Statements deleting the Intellectual Property Collateral for all UCC financing statements naming Artistica and/or Artistica, LLC as a debtor and Secured Party as the secured party, and (iii) undertakes that promptly, upon request and at no cost to Secured Party, it shall execute and deliver all other appropriate documents, instruments or releases reasonably deemed necessary to further evidence the termination, release and discharge of the aforementioned security interest in, liens on, and all other rights in, to and under the Intellectual Property Collateral.

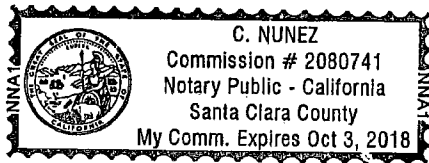
