**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October **21**, 2016 (“Release”), is made by PNC Bank, National Association, as Agent (“Agent”) in favor of Thompson Mahogany Company (formerly ETFH Acquisition Corporation), a Delaware corporation (“Grantor”).

WHEREAS, pursuant to that certain Revolving Credit, Term Loan and Security Agreement dated as of April 13, 2006 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Grantor, Agent, and others party thereto, Grantor assigned, pledged, and granted to the Agent, for its benefit and for the ratable benefit of each Lender (collectively, the “Secured Parties”), a continuing security interest in and Lien on all of Grantor’s Collateral, including General Intangibles, trademarks, trademark applications, service marks, and goodwill, and proceeds of the foregoing (collectively, “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Agent, for the benefit of the Secured Parties, the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on November 11, 2009 at Reel 4094 Frame 0709 (“Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:


(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and Lien on and security interest in all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
