RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (this "Release") is made as of October 17, 2016 ("Effective Date") by and between E4 HEALTH, INC. ("Grantor") and PROSPERITY BANK (as successor by merger to the F&M Bank & Trust Company) (the "Lender").

WHEREAS, Grantor and the Lender entered into that certain Loan and Security Agreement by and between Grantor, the Lender and the other parties thereto dated December 21, 2013 (the "Guaranty and Security Agreement");

WHEREAS, pursuant to the Guaranty and Security Agreement, Grantor granted to the Lender a lien on and security interest in all of its right, title and interest in, to and under certain intellectual property and entered into that certain Intellectual Property Security Agreement dated December 13, 2013 (the "Intellectual Property Security Agreement") for the purpose of recording such security interest with respect to the copyrights, patents and trademarks of Grantor, including those items set forth on Schedule A, Schedule B and Schedule C hereto (the "Intellectual Property Collateral") with the United States Patent and Trademark Office and the United States Copyright Office;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on January 2, 2014, at Reel 5187, Frame 0162; and the United States Copyright Office on January 16, 2014, at Volume V9908, Page D188; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to the Lender.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby (i) terminates the Intellectual Property Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral, and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under the Intellectual Property Collateral to Grantor.

The Lender represents and warrants that: (x) it has the full power and authority to execute this Release; (y) it has not assigned, transferred, restricted or otherwise encumbered any right, title or interest it has in, to and under the Intellectual Property Collateral; and (z) it has not recorded or otherwise evidenced its security interest in the United States Patent and Trademark Office and United States Copyright Office with respect to any copyright patent and trademark, or any registration of or application to register the foregoing, or any patent application, owned by Grantor other than those set forth on Schedule A, Schedule B and Schedule C.

The Lender shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
