ASSIGNOR covenants that ASSIGNOR is the owner of the Marks, that ASSIGNOR has full power to make this Assignment and that ASSIGNOR agrees to execute such further assignments and related documents with respect to the Marks and the Goodwill as ASSIGNEE shall reasonably request.

ASSIGNOR and ASSIGNEE agree that this Assignment is subject to the Assignment of Intellectual Property and Royalty Agreement dated April 8, 2016 (the "Agreement"), in the event of a conflict between this Assignment and Agreement, the terms of the Agreement shall prevail.
