Madison shall take all further actions, and provide to Company, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Company to more fully and effectively effectuate the purpose of this Release at the expense of Company.
