TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement") is entered into this 27 day of October, 2016 (the "Effective Date") by and between Jill Pakulski Weeks, located at 805 Ninth Street, Oakmont, Pennsylvania 15139 ("Assignor"); AND

Note To Health, LLC, d.b.a. Jump with Jill, a limited liability company organized under the laws of the State of Pennsylvania, located at 805 Ninth Street, Oakmont, Pennsylvania 15139 ("Assignee").

Assignor and Assignee are hereinafter referred to, individually, as "Party" and collectively, as "Parties".

WHEREAS, Assignor owns the entire right, title and interest in and to the twelve United States registered trademarks and the one United States trademark application listed in Appendix A attached hereto, together with all the goodwill of the business symbolized thereby, (the "Trademarks");

WHEREAS, Assignee desires to acquire the Trademarks from Assignor in accordance with the terms and conditions of this Agreement.

NOW, THEREFORE, the Parties hereto agree as follows:

1. For valuable consideration, the receipt whereof is hereby acknowledged, the Assignor does hereby assign to Assignee all rights, title and interests derived from and in connection with the Trademarks.
2. Assignor represents and warrants that she is the sole proprietor of all rights, title and interests derived from and in connection with the Trademarks, and that the assignment of the Trademarks from Assignor to Assignee shall not cause any infringement of industrial property rights of any third party. The Trademarks are assigned in their present legal status, which is known to Assignor. To Assignor's best knowledge, there are no pending cases before the court or national authorities, which may adversely affect the Trademarks. Assignor does not make any further guarantees.
3. This Agreement shall be binding on and shall inure to the benefit of the Parties to this Agreement and their successors and assigns, if any.
4. This Agreement constitutes the entire agreement of the Parties with regard to the subject matter hereof. No modifications of or additions to this Agreement shall have effect unless in writing and properly executed by both Parties, making specific reference to this Agreement by date, parties, and subject matter.
5. This Agreement and the rights and obligations of the Parties hereunder shall be governed by and construed in accordance with the laws of Pennsylvania, without regard to its conflict of laws principles, and shall be enforceable against the Parties in the courts of Pennsylvania.
6. If any provision of this Agreement or portion thereof is determined by a court of competent jurisdiction, or declared under any law, rule or regulation of any government having jurisdiction over the Parties hereto, to be invalid, illegal or otherwise unenforceable, then such provision will, to the extent permitted by the court or government not be voided but will instead be construed to give effect to its intent to the maximum extent permissible under applicable law, and the remainder of this Agreement will remain in full force and effect according to its terms.
7. Each Party acknowledges that it has read this Agreement, understands it and agrees to be bound hereby, and represents and warrants that the individual executing this Agreement on its behalf is duly authorized to enter into this Agreement.
