**RELEASE OF SECURITY INTEREST

WHEREAS, pursuant to the Second Lien Intellectual Property Security Agreement, dated as of April 30, 2015 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on May 5, 2015 at Reel/Frame No. 5510/0006, Genoa Healthcare, LLC granted the Agent a security interest in certain collateral pledged by the Grantor described therein, including, without limitation, the United States trademark set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Grantor has requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.




