**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of October 26, 2016 in favor of SIZMEK TECHNOLOGIES, INC. as successor in interest to ENLIVEN MARKETING TECHNOLOGIES CORPORATION, a Delaware corporation (“Debtor”), by BANK OF MONTREAL, in its capacity as administrative agent (the “Agent”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

**WHEREAS**, Debtor and the Agent entered into that certain Amended and Restated Security Agreement by and among Debtor, the Agent and the other parties thereto dated March 13, 2008 (the “Security Agreement”);

**WHEREAS**, pursuant to the Security Agreement, Debtor granted to the Agent a lien on and security interest in, for the benefit of the Secured Parties, all of its right, title and interest in, to and under certain intellectual property, including trademarks and registered trademarks and logos, and, in connection therewith, entered into that certain Trademark Security Agreement dated November 3, 2008 (the “Trademark Security Agreement”) for the purpose of recording such security interest with respect to the trademarks of Debtor with the United States Patent and Trademark Office;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 3, 2008, at Reel 3886, Frame 0063; and

**WHEREAS**, Debtor has requested that the Agent release its lien on and security interest in the items set forth on Schedule A hereto (the “Released Trademarks”).

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (a) terminates, cancels, discharges and releases any and all security interests it has in, to and under (i) the Released Trademarks, (ii) all proceeds and products of the Released Trademarks, (iii) the goodwill associated with the Released Trademarks, (iv) all renewals, applications, and extensions of the Released Trademarks, and (v) any causes of action arising prior to the date hereof for infringement of any of the Released Trademarks or unfair competition regarding the same, and (b) re-assigns to Debtor any right, title and interest it may have in, to and under the Released Trademarks and authorizes and requests the United States Patent and Trademark Office, and any other location where the security interest was filed, to note and record the existence of such release hereby given.

The Agent will, at Debtor’s sole expense, take all further actions, and provide to Debtor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Debtor to more fully and effectively effectuate the purposes of this Release.

The execution and delivery of this Release is without recourse to or warranty by the Agent.

This Release shall be governed by and construed in accordance with the laws of the State of New York.




