## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 31, 2016 (“Release”), is made by NewStar Financial, Inc., as administrative agent (“Administrative Agent”) for itself, its successors and permitted assigns, and the other Lenders (as defined in the Credit Agreement referred to below) in favor of each of the entities listed on the signature pages hereof (each a “Grantor” and, collectively, the “Grantors”).

**WHEREAS**, pursuant to the Credit Agreement dated as of May 7, 2015 (as amended by the First Amendment to Credit Agreement dated as of August 3, 2015, and as further amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) iSqFt Sub, Inc. (f/k/a Blueprint Sub Inc.), a Delaware corporation (the “Borrower”), the other Credit Parties party thereto (collectively, with the Borrower, the “Guarantors”), the Lenders party thereto and the Administrative Agent on behalf of the Lenders under the Credit Agreement, and pursuant to the Notice of Grant of Security Interest in Trademarks dated as of May 7, 2015 and August 3, 2015 (collectively, the “Trademark Security Agreements”), each Grantor has granted a continuing security interest in and continuing lien upon the trademark registrations and trademark applications shown on Schedule A (the “Trademarks”);

**WHEREAS**, the Trademark Security Agreements were recorded at the United States Patent and Trademark Office (“USPTO”) on May 19, 2015 at Reel 5519 Frame 0772 and on August 3, 2015 at Reel 5590 Frame 0415; and

**WHEREAS**, Administrative Agent (acting at the written direction of the Lenders) now desires to terminate and release the entirety of its security interest in the Trademarks.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent (for itself and as Administrative Agent for the Lenders) and the Grantors (the “parties”) agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Credit Agreement or Trademark Security Agreements.

**SECTION 2. Termination and Release.** The Administrative Agent (acting at the written direction of the Lenders), for itself and as Administrative Agent for the Lenders, hereby:

(a) terminates, releases, and discharges its continuing security interest in and continuing lien upon the Trademarks. Any and all right, title, or interest of Administrative Agent in the Trademarks and all proceeds thereof, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Trademarks and any and all causes of action which may exist by reason of infringement of the Trademarks, shall hereby cease and become void;

(b) authorizes the recordation of this Release with the USPTO;

(c) releases without any recourse to the Administrative Agent (whether as Administrative Agent or in its personal capacity) and without any statement, representation, warranty, promise or undertaking whatsoever by the undersigned (whether as Administrative Agent or in its personal capacity); and

(d) agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantors may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantors' counsel and the cost and expense of such documents and actions shall be borne solely by the Grantors.

This release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
