FIRST SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This First Supplement to Intellectual Property Security Agreement (this “*Supplement*”) is made as of October 31, 2016 by and between (i) **SILICON VALLEY BANK**, a California corporation, with a loan production office located at 275 Grove Street, Suite 2-200, Newton, Massachusetts 02466 (“*Bank*”) and (ii) (a) **DIALOGIC (US) INC.**, a Delaware corporation (“*Dialogic US*”), (b) **DIALOGIC INC.**, a Delaware corporation (“*Dialogic*”), (c) **DIALOGIC US HOLDINGS INC.**, a Delaware corporation (“*Holdings*”), (d) **DIALOGIC DISTRIBUTION LIMITED**, a company incorporated and existing under the laws of Ireland with registered number 201976 and whose registered address is Riverside One, Sir John Rogerson’s Quay, Dublin 2 (“*Dialogic Distribution*”), (e) **DIALOGIC MANUFACTURING LIMITED**, a company incorporated and existing under the laws of Ireland with registered number 182638 and whose registered address is Riverside One, Sir John Rogerson’s Quay, Dublin 2 (“*Dialogic Manufacturing*”), (f) **DIALOGIC CORPORATION**, a corporation continued under the laws of the Province of British Columbia (“*Dialogic Canada*”), and (g) **DIALOGIC GROUP INC.**, a Canadian federal corporation (“*Dialogic Group*”; Dialogic US, Dialogic, Holdings, Dialogic Distribution, Dialogic Manufacturing, Dialogic Canada and Dialogic Group are referred to herein, each and together, jointly and severally, as “*Grantor*”), with offices located at c/o Dialogic (US) Inc., 4 Gatehall Drive, Parsippany, New Jersey 07054.

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated June 29, 2015 (as amended of record from time to time hereinafter, the “*Agreement*”) in favor of the Bank, pursuant to which the Grantor pledged, assigned and granted a security interest in certain Intellectual Property Collateral (as defined therein); and

WHEREAS, the Grantor developed additional Patents and/or Patent Applications and desire to hereby confirm the pledge of, and the grant of a security interest in, such additional Patents and/or Patent Applications in favor of Bank;

WHEREAS, the Grantor developed additional Trademarks and/or Trademark Applications and desire to hereby confirm the pledge of, and the grant of a security interest in, such additional Trademarks and/or Trademark Applications in favor of Bank; and

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
2. Supplement to Exhibit B and Exhibit C. Exhibit B and Exhibit C to the Grant are hereby supplemented, but not replaced, by Exhibit B-1 and Exhibit C-1 annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.


- b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.


