**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

Further, Agent understands and agrees that this Release may be recorded by or for Grantor with the United States Patent and Trademark Office and any other similar office or agency throughout the world. Agent also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Grantor may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
