Embrane has assigned and transferred, and Cisco has received and accepted, all of Embrane's rights, title and interest throughout the world in and to the Embrane Marks and all the rights, claims and privileges pertaining to the Embrane Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Embrane Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Embrane in all matters related thereto.


Embrane hereby authorizes and requests the United States Commissioner of Patents and Trademarks to implement this Assignment.
