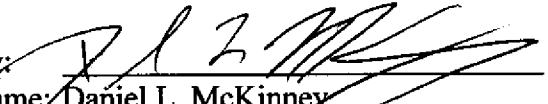

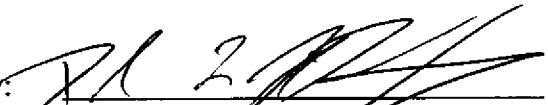
8. Immediately following the merger, the name of the **surviving entity** shall be Digital Electronic Supply, LLC.
