TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Assignment") is entered into as of the 19th day of October, 2016, by and between Opici I.P. Holdings LLC, a New Jersey limited liability company, having an address of 25 De Boer Drive, Glen Rock, NJ 07452 ("Assignor"), and Luxco, Inc., a Missouri corporation, having an address at 5050 Kemper Avenue, St. Louis Missouri 63139 ("Assignee").

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the REBELLION trademark and REBELLION RUM trademark, including U.S. Patent and Trademark Office Trademark Registration Numbers 4407601 and 4609989 for "REBELLION" and "REBELLION RUM", and all goodwill associated with the foregoing (collectively, the "REBELLION Marks");

WHEREAS, Assignor and Assignee have entered into an Asset Purchase & Sale Agreement, ("Asset Purchase Agreement"), in which Assignor has agreed to sell and transfer to Assignee all right, title and interest in and to the REBELLION Marks and associated goodwill;

WHEREAS, Assignor therefore wishes to assign the entire rights, title and interest in and to the REBELLION Marks including the goodwill associated therewith to Assignee, and Assignee desires to accept the REBELLION Marks including the goodwill associated therewith.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

1. Assignor hereby transfers and assigns to Assignee its entire right, title and interest in and to the REBELLION Marks, together with the goodwill associated therewith, including without limitation, the right to sue for past infringement, and all registrations and applications therefor, including U.S. Trademark Registration Numbers 4407601 and 4609989.

2. This Assignment shall inure to the benefit of, and be binding upon the parties, their successors and assigns.
