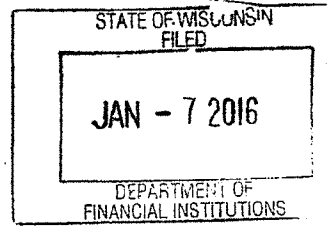

ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
NWP, INC.



The undersigned hereby adopts the following Articles of Amendment to the Articles of Incorporation for NWP, Inc., a Wisconsin corporation (the "Corporation"), under the Wisconsin Business Corporation Law, Chapter 180 of the Wisconsin Statutes.

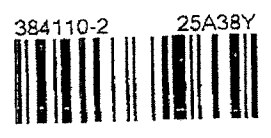
