**CERTIFICATE OF AMENDMENT

ARTICLES OF INCORPORATION

BE IT FURTHER RESOLVED, that the Effective Date of this Amendment shall be October 1, 2010."

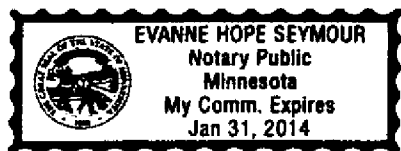
