**TERMINATION OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARK RIGHTS**, dated as of October 4, 2016 (this "Termination"), is made by COMMSCOPE, INC. OF NORTH CAROLINA, a North Carolina corporation, as agent (in such capacity, the "Agent") for the Lenders under that certain Grant of Security Interest in Trademark Rights, dated as of December 11, 2013 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among COPPERWELD BIMETALLICS LLC, a Delaware limited liability company (the "Grantor") and the Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on December 13, 2013 at Reel 5173, Frame 0111, the Grantor granted to the Agent, for the benefit of the Lenders, a security interest in all of Grantor's right, title and interest in, to and under all of its Trademark Collateral, including, without limitation those set forth on the attached Schedule A; and

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest created under the Trademark Security Agreement in the Released Collateral, and (c) discharge any and all rights, title and interest it has in, and the security interest granted to the Agent in the Released Collateral under the Trademark Security Agreement.
