Just Fabulous, Inc., a Delaware corporation (the “Corporation”), does hereby certify as follows:

**FIRST:** The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on April 30, 2010, as amended by the Certificate of Amendment to the Certificate of Incorporation filed with the Secretary of State of the State of Delaware on November 29, 2010. A Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on September 13, 2011. A Second Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on July 16, 2012. A Third Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on January 22, 2013. A Fourth Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on August 29, 2013. A Fifth Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on November 27, 2013. A Sixth Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on July 29, 2014, as amended by the Certificate of Amendment to the Sixth Amended and Restated Certificate of Incorporation filed with the Secretary of State of the State of Delaware on March 31, 2015 (the “Prior Certificate”).

**SECOND:** Article I of the Prior Certificate is hereby amended to read in its entirety as set forth below:

“The name of this corporation is TechStyle, Inc.”

**THIRD:** The foregoing amendment to the Prior Certificate has been duly adopted in accordance with Section 242 of the General Corporation Law of the State of Delaware.
