NUNC PRO TUNC TRADEMARK ASSIGNMENT

THIS NUNC PRO TUNC TRADEMARK ASSIGNMENT is effective August 2, 2011, by and between **GRABOID INTERNATIONAL INC.**, a Barbadian company, with a principal place of business at L'Horizon, Gunsite Road, Brittons Hill, St. Michael, Barbados ("Assignor") and **SIMPLY AUDIOBOOKS INC.**, a company incorporated pursuant to the laws of Canada, with a principal place of business at 935 Sheldon Court, Burlington, Ontario L7L 5K6, Canada ("Assignee").

WHEREAS, Assignor and Assignee wish to formally document and clarify such trademark assignment that occurred on August 2, 2011.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby confirms that as of August 2, 2011, it has sold, assigned, transferred, conveyed and delivered to Assignee all right, title and interest in and to the Assigned Trademark, together with the goodwill of the business symbolized thereby, together with the registration identified above and all past, present, and future remedies for infringement or dilution relating thereto, including the right to sue for and collect damages by reason of past infringement of the Assigned Trademark with the intent that such Assigned Trademark and the aforementioned related rights shall be fully vested in the Assignee, its successors and assigns, as and from August 2, 2011.

Assignor acknowledges that as of August 2, 2011, Assignee became the exclusive owner of the Assigned Trademark and the goodwill associated therewith; and

Assignor further authorizes the Commissioner of Patents and Trademarks of the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the Assigned Trademark and title thereto as the property of the Assignee, its successors, legal representatives and assigns in accordance with the terms of this assignment.
