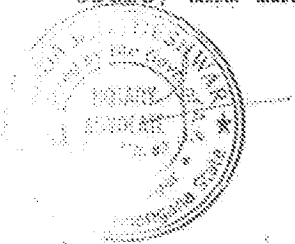
THIS AGREEMENT entered ^{Aug} ~~June~~ 22 ~~2015~~ 2016 between SRINIVAS

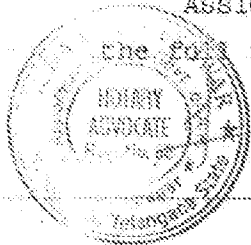
goodwill of the business symbolized and associated with SAID TRADEMARK, all common law and statutory right, title, and interest in and to SAID TRADEMARK, all the rights in the application, registration, maintenance, renewal and protection thereof, and all the rights of recovery and legal action for past infringements and of opposition and/or cancellation proceeding for protection of SAID TRADEMARK, in the United States.

ASSIGNOR hereby authorizes ASSIGNEE, to the fullest extent permitted by applicable law, to file in its own name applications for trademark and copyright registration in the U.S. in connection with SAID TRADEMARK, and to secure in its own name the registrations granted thereon.

ASSIGNOR also authorizes ASSIGNEE to take any action necessary to effect the transfer of SAID TRADEMARK to ASSIGNEE or prosecute or otherwise enforce any claims, rights, or benefits relating to SAID TRADEMARK.

ASSIGNOR hereby further authorizes the Commissioner of Patents and Trademarks of the United States to record this Assignment, and to issue or transfer all rights, title, and interest in and to SAID TRADEMARK to the ASSIGNEE as owner of full and exclusive right, title and interest in and to SAID TRADEMARK, or otherwise as the ASSIGNEE may direct, in accordance with the terms of this Assignment.

ASSIGNOR hereby represents and warrants that ASSIGNOR has the full right to convey the entire right, title and interest



herein assigned, that there are no rights or interests outstanding inconsistent with the rights and interests granted herein, and that ASSIGNOR will not execute any instrument or grant or transfer any rights or interests inconsistent with the rights and interests granted herein.

ASSIGNOR further covenants and agrees that upon request, and at Assignor's request, that it will sign any papers reasonably to effectuate the transfer and assignment herein to ASSIGNEE in the United States Patent and Trademark Office.

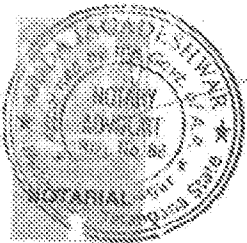
