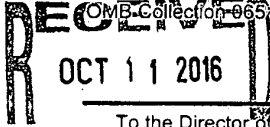

ASSIGNMENT OF INTELLECTUAL PROPERTY

RECITALS

WHEREAS, Assignor is the owner of (a) all inventions (whether patentable or unpatentable and whether or not reduced to practice), all improvements thereto, and all patents, patent applications, and patent disclosures, together with all reissuances, continuations, continuations-in-part, revisions, extensions, and reexaminations thereof; (b) Assignor’s corporate name and all fictitious trade names, trademarks, service marks, trade dress, logos, together with all translations, adaptations, derivations, and combinations thereof and including all goodwill associated therewith, and all applications, registrations, and renewals in connection therewith; (c) all copyrightable works, all copyrights, and all applications, registrations, and renewals in connection therewith; (d) all mask works and all applications, registrations, and renewals in connection therewith; (e) all trade secrets and confidential information, including ideas, research and development, know-how, formulas, compositions, manufacturing and production processes and techniques, technical data, designs, drawings, specifications, client account and supplier lists, pricing and cost information, and business and marketing plans and proposals); (f) all Software (including data and related documentation); (g) all registered domain names, website content, website related software, and all other Internet related tools and applications; (h) all other proprietary rights; and (i) all copies and tangible embodiments thereof (in whatever form or medium), including but not limited to those described on the list attached hereto as **Exhibit A** (“Intellectual Property”); and

Assignor irrevocably constitutes and appoints Assignee, and any officer or agent thereof, with full power of substitution, as its true and lawful attorney-in-fact with full irrevocable power and authority in the place and stead of Assignor and in the name of Assignor or in its own name, from time to time in the discretion of Assignee or its designees, for the purpose of carrying out the terms of this Assignment, to take any and all appropriate actions and

to execute any and all documents and instruments which may be necessary or desirable to accomplish the power and right, on behalf of Assignor to do the following:

(a) to institute and prosecute any and all proceedings which Assignee may deem proper in order to collect, assert or enforce any claim, right or title of any kind in or to any of the Assets, to defend or compromise any and all actions, suits or proceedings in respect of any of the Assets, and to do such acts and things in relation thereto as Assignee shall deem advisable; and


