THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of October 3, 2016 by and between Thomson Reuters (Professional) UK Limited, a limited company organized according to the laws of Great Britain, with its principal office at 160 Blackfriars Road, London SE1 8ES, UK ("Assignor") and NetResult Solutions Limited, a limited company organized according to the laws of Great Britain, with its principal office at 1 Mark Square, Leonard Street, 2<sup>nd</sup> Floor, London, EC2A 4EG UK ("Assignee").


WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, Assignor's entire right, title and interest in and to the United States registrations set forth on Schedule A hereto, together with the goodwill of the business associated therewith (collectively the "Marks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:


1. Assignor hereby sells, assigns, transfers, conveys and grants to Assignee, its successors and assigns, Assignor's entire right, title, benefit, privilege and interest in and to the Marks, including, without limitation, all statutory and common law rights and all rights, power, liberties and immunities attaching to the Marks, without limitation, the following: (A) the right to apply for all extensions and renewals with respect to the marks, from the date hereof to the full end of the term or terms for which the Marks may be issued, the same to be held and enjoyed by Assignee, its successors and assigns to the same extent that it would have been held and enjoyed by Assignor if this Assignment had not been made; and (B) the registrations of and/or applications to register the trademarks identified on Schedule A hereto, the goodwill of the business symbolized by said trademarks and the registrations thereof, and the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present and future infringements or dilution of or damage or injury to said trademarks or the registrations thereof or associated goodwill.
2. Assignor hereby requests the Commissioner of Trademarks of the United States Patent and Trademark Office to record Assignee as the assignee and owner of the Marks.
3. This Assignment and the rights and obligations of Assignee and Assignor hereunder shall be governed by, and shall be construed and interpreted in accordance with, the laws of the State of New York.
4. This Assignment may be executed by one or more parties to this Assignment on any number of separate counterparts (including by telecopy), and all said counterparts taken together shall be deemed to constitute one and the same instrument.
