WHEREAS, Assignee desires to receive from Assignor all of said, right, title and interest in the Scheduled Mark;



Assignor agrees to execute such further papers and do such other acts as may be necessary to obtain or assign the Scheduled Mark, including but not limited to, any acts which may be necessary, desirable or convenient for claiming said priority rights and perfecting Assignee's title in the Scheduled Mark.
