TRADE MARK ASSIGNMENT

BETWEEN:

- (1) Matthew Timothy Horan, a United Kingdom citizen, of 43a School Road, Oldland Common, Bristol, United Kingdom, BS30 6PH ("the Assignor"); and
- (2) Rollasole Limited, aa United Kingdom company, of 9 Portland Square, Bristol, United Kingdom, BS2 8ST ("the Assignee").

Whereas:

- (A) The Assignor is the registered proprietor of the trade marks listed on Schedule 1 ("the Trade Marks").
- (B) The Assignor has agreed to assign to the Assignee the Trade Marks and all common law and unregistered rights connected therewith together with the goodwill of the business of the Assignor concerned in the goods upon following terms and conditions.

Now it is hereby agreed and declared as follows:

1 Assignment

In pursuance of the said agreement and in consideration of the sum of £1.00 now paid by the Assignee to the Assignor (the receipt whereof the Assignor hereby acknowledges) the Assignor with full title guarantee HEREBY ASSIGNS unto the Assignee the Trade Marks and all common law and unregistered rights connected

therewith and the full and exclusive benefit of them together with the goodwill of the business of the Assignor concerned in the goods in respect of which the Trade Marks are registered TO HOLD the same unto the Assignee absolutely.

2 Assignor's obligations and warranties:

2.1 The Assignor shall at the discretion and expense of the Assignee execute any further document and do any such thing as the Assignee may require to enable the Assignee to become registered as the proprietor of the Trade Marks.

2.2 The assignor hereby warrants that:

2.2.1 it is the proprietor of the Trade Marks and has the full power to enter into this Assignment;

2.2.2 it has not granted any licenses to use the Trade Marks;


2.2.3 it has not, either by act or omission, caused and permitted anything to be done which might endanger the validity of the Trade Marks or the ability of the Assignee to register this Assignment;

2.2.4 it has not knowingly withheld from the Assignee knowledge of any circumstances that may endanger the validity of the Trade Marks or the ability of the Assignee to register this Assignment.

2.3 The Assignor hereby agrees to indemnify, and to keep the Assignee indemnified, against all actions, claims, proceedings, costs and damages (including any damages or compensation paid by the Assignee on the advice of its legal advisors to compromise or settle any claim) and all legal costs and other expenses arising out of any breach of the warranties in clause 2.2 or out of any claims by a third party based on any facts which, if substantiated, would constitute such a breach.


