

AND ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any country or countries

foreign to the United States whose duty it is to issue Trademarks on applications as aforesaid, to issue to said ASSIGNEE, as assignee of the entire right, title and interest, any and all Trademarks for Trademark Property, including any and all Trademark Registrations of the United States which may be issued and granted on or as a result of any applications included in said Trademark Property, in accordance with the terms of this assignment. ASSIGNOR does hereby expressly agree that ASSIGNEE may singly, and without assistance or consent from ASSIGNOR, undertake procedures to record the transfer of the Trademarks to ASSIGNEE in the United States Patent and Trademark Office.


