The Assignee makes no guarantees or warranties in connection with the URL or Trademark, except that to the best of his knowledge and belief he and/or his Trust is the present owner. The parties agree that the Assignor has no duties or responsibilities related to this Trademark after the assignment date, except to attest to the validity of this Assignment.
