RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is made as of September 26, 2016 in favor of UNICAST COMMUNICATIONS CORP., a Delaware corporation (“Grantor”) by SILICON VALLEY BANK., in its capacity as Lender (the “Lender”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit Agreement (as defined below).

WHEREAS, Grantor and Lender entered into that certain Loan and Security Agreement by and between Grantor, Lender and the other parties thereto dated April 12, 2000 (the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, Grantor granted to the Lender a security interest in all of its right, title and interest in, to and under certain intellectual property, including trademarks and registered trademarks and logos, including those on Schedule A hereto (the “Trademarks”) and certain patents and patent applications, including those on Schedule B hereto (the “Patents”), and, in connection therewith, entered into that certain Intellectual Property Security Agreement dated April 12, 2000 (the “Intellectual Property Security Agreement”) for the purpose of recording such security interest with respect to the Trademarks and Patents of Grantor with the United States Patent and Trademark Office;

WHEREAS, the Intellectual Property Security Agreement was recorded with respect to the Trademarks with the United States Patent and Trademark Office on May 17, 2000, at Reel 2074, Frame 0067 and with respect to the Patents with the United States Patent and Trademark Office on April 26, 2000 at Reel 010784, Frame 0357; and

WHEREAS, Grantor has requested that the Lender release its security interest in the Trademarks and Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby (a) terminates, cancels, discharges and releases any and all security interests it has in, to and under (i) the Trademarks and Patents, (ii) all proceeds and products of the Trademarks and Patents, (iii) the goodwill associated with the Trademarks and Patents, (iv) all renewals, applications, and extensions of the Trademarks and Patents, and (v) any causes of action arising prior to the date hereof for infringement of any of the Trademarks and Patents or unfair competition regarding the same, and (b) re-assigns to Grantor any right, title and interest it may have in, to and under the Trademarks and Patents and authorizes and requests the United States Patent and Trademark Office, and any other location where the security interest was filed, to note and record the existence of such release hereby given.

The Lender will, at Grantor’s expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

The execution and delivery of this Release is without recourse to or warranty by the Lender.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
