TERMINATION AND RELEASE OF SECURITY INTEREST IN
U.S. TRADEMARKS

United States Patent & Trademark Office

This Termination and Release of Security Interest in U.S. Trademarks dated this 21 day of October, 2016 from ROCKLAND TRUST COMPANY ("the Bank") is made pursuant to the SECOND MODIFICATION TO STANDARD REVOLVING FINANCING AGREEMENT AND SECOND AMENDMENT TO SECURITY AGREEMENT AND INTELLECTUAL PROPERTY SECURITY AGREEMENT FOR PATENTS AND TRADEMARKS AND INTELLECTUAL PROPERTY SECURITY AGREEMENT FOR COPYRIGHTS entered into on December 3, 2013 (the "Agreement") between the Bank and MEDPORT LLC, a Rhode Island limited liability company ("Grantor").

WHEREAS, pursuant to the Agreement a security interest was granted by the Grantor to the Bank in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, the Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 3, 2013 at Reel 5168 and Frame 0546; and

WHEREAS, the Bank now desires to terminate and release the entirety of its Security Interest in the Specified Trademark Collateral;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby agrees as follows:

1. Definitions. The term "Specified Trademark Collateral", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks and trademark applications set forth on Schedule I attached hereto.

2. Release of Security Interest. The Bank hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral without representation, warranty or recourse of any kind or nature.
