**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

November 10, 2016

WHEREAS, Dwellworks, LLC, a Delaware limited liability company and certain of its affiliates from time to time party thereto (collectively, the “Companies” and each, a “Company”) entered into (i) a Security Agreement, dated as of December 23, 2014 (as from time to time amended, modified or supplemented, the “Security Agreement”; capitalized terms used herein and not otherwise defined shall have the meanings assigned thereto in the Security Agreement) by the Companies in favor of The Huntington National Bank, a national banking association, as agent (the “Agent”) for the ratable benefit of the Secured Creditors referenced therein and (ii) a Patent and Trademark Security Agreement, dated as of December 23, 2014 (as from time to time amended, modified or supplemented, the “Patent and Trademark Security Agreement” and, together with the Security Agreement, the “Agreements”) by certain of the Companies in favor of the Agent, pursuant to which each such Company granted a security interest (the “Security Interest”) in all of such Company’s right, title and interest in and to the Trademarks, including without limitation the trademarks and trademark applications set forth on the attached Schedule A, all to the extent set forth in the Agreements; and

WHEREAS, all of the Obligations have been fully paid and satisfied and the Agent desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent hereby releases the Security Interest in the Trademarks listed on Schedule A annexed hereto, and hereby, (i) waives and relinquishes all its rights, powers, privileges and remedies under the Agreements with respect to the Trademarks, (ii) assigns, conveys, transfers and sets over to the applicable Company any right, title or interest that the Agent may have acquired and re-vests in the applicable Company the full unencumbered title to the Trademarks and the goodwill associated therewith, and (iii) releases each Company from all covenants, obligations, liabilities and warranties under the Agreements related to the Trademarks.
