RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of November 10, 2016 (this "Release") is made by Venture Lending & Leasing VI, Inc. and Venture Lending & Leasing VII, Inc., both Maryland corporations (referred to together as the "Secured Party"), under the Intellectual Property Security Agreement dated as of May 22, 2014 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and The Black Tux, Inc., a Delaware corporation (the "Debtor") and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 5290, Frame 0963.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademarks, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement. Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Debtor's expense, as may be reasonably necessary to effect the release of the security interest in the Trademarks contemplated hereby.
