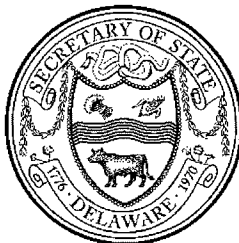



**Fifth:** The name of the surviving foreign Corporation is CONTECH CONSTRUCTION PRODUCTS INC.


