RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Release") is made as of November 4, 2013 by BARCLAYS BANK PLC, as collateral agent for the Secured Parties (and, to the extent provided in Section 7.1 of the Pledge and Security Agreement (as defined below), the Debenture Trustee on behalf of the 2023 Debentures Holders) (in such capacity, together with its successors and permitted assigns, the "Collateral Agent") in favor of PVH Corp., a Delaware corporation (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Pledge and Security Agreement.

WHEREAS, the Grantor executed and delivered to the Collateral Agent a U.S. Pledge and Security Agreement dated as of February 13, 2013 (the "Pledge and Security Agreement");

WHEREAS, pursuant to the terms and conditions of the Pledge and Security Agreement, the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties (and, to the extent provided in Section 7.1 of the Pledge and Security Agreement, the Debenture Trustee on behalf of the 2023 Debentures Holders), a security interest in and continuing lien on (the "Security Interest") all of the Grantor's right, title and interest in, to and under the Released Trademark Collateral (as defined below); and

WHEREAS, in connection with the Grantor's sale of the Released Trademark Collateral, the Collateral Agent desires to terminate the Security Interest in the Released Trademark Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The term "Released Trademark Collateral," as used herein, means (a) the trademarks listed on Schedule A attached hereto, (b) all registrations therefor, and all extensions and renewals thereof, (c) all of the goodwill of the business connected with the use of and symbolized by any of the foregoing, (d) all rights to sue or otherwise recover for any past, present and future infringement, dilution or other violation of any of the foregoing or for any injury to the related goodwill, (e) all Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect thereto, and (f) all other rights of any kind accruing thereunder or pertaining thereto throughout the world.
2. The Collateral Agent, for the benefit of the Secured Parties (and, to the extent provided in Section 7.1 of the Pledge and Security Agreement, the Debenture Trustee on behalf of the 2023 Debentures Holders), hereby terminates and releases the Security Interest in the Released Trademark Collateral, and retransfers and reassigns to the Grantor any right, title or interest the Collateral Agent may have in or to the Released Trademark Collateral, without representation or warranty.




