3. After the date hereof, Assignor shall execute and deliver, without additional expense to Assignee, such additional documents as are reasonably necessary to consummate,

effectuate or evidence the transaction contemplated herein. Upon execution, Assignor shall file this Assignment with the United States Patent and Trademark Office and forward a copy of the filing receipt to Assignee.

4. Assignor hereby represents, warrants and covenants: (a) that the Registrations are valid, subsisting and still in force; (b) that it has taken all action necessary to authorize execution of this Assignment; (c) that this Assignment and each of its terms are binding; (d) that it has the requisite power and authority to perform the acts stated herein; (e) that the undersigned signatory has the full legal right, power and authority to bind Assignor; (f) that it has not assigned or delegated to any third party all or any part of the rights and obligations set forth herein; and (g) that it owns and has not assigned, conveyed, pledged, encumbered or otherwise transferred, in whole or in part, the Registration or its common law rights.
