SECOND LIEN RELEASE AND REASSIGNMENT OF
TRADEMARKS AND TRADEMARK APPLICATIONS

WHEREAS, the Grantee wishes to terminate, cancel, release, relinquish and discharge its continuing security interest, and retransfer and reassign to the Grantor, without representation or warranty, all of the Grantor's right, title and interest in and to the Marks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantee hereby terminates, cancels, releases, relinquishes and discharges its continuing security interest, and retransfers and reassigns to the Grantor, without representation or warranty, all of the Grantee's right, title and interest in and to the Marks and reassigns to the Grantor any and all such right, title and interest in and to the Marks.

The Grantee hereby agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the termination, cancellation, release, relinquishment, discharge, retransfer and reassignment of the continuing security interest contemplated hereby. The parties hereto or their designees (including counsel to the Grantee, Milbank, Tweed, Hadley & McCloy who are hereby so designated) may record this Second Lien Release and Reassignment of Trademarks and Trademark Applications (this "Release") in the USPTO and in any other offices as may be necessary to carry out the intention of this Release and, to the extent applicable, the parties hereto authorize and request that the USPTO record this Release.
