## Trademark Assignment Agreement

THIS AGREEMENT, entered into as of 30th day of March, 2016 by and between Kyorin Co., Ltd., a corporation duly organized and existing under the law of Japan, having its principal office of business at 9, Shirogane-machi, Himeji city, Hyogo, Japan (hereinafter called "Assignee") and Kyorin Group (China) Ltd., a corporation duly organized and existing under the law of Hong Kong, China, having its principal office of business at Unit16-18, 5/F., Pacific Trade Centre, 2 Kai Hing Road, Kowloon Bay, Kowloon, Hong Kong (hereinafter called "Assignor"),

WITNESSETH:

WHEREAS,

- 1) The Assignor is the registered proprietor of the U.S. trademark BIO-PURE (hereinafter referred to as the MARK);
- 2) The Assignor is willing to assign and transfer all rights and interest to the Assignee of the MARK upon such terms and conditions as are hereinafter set out;

NOW, it is hereby agreed as follows:

### Article 1. Definitions

Wherever the following term is used in this Agreement, it shall have the meaning specified below:

"MARK" shall mean the following trademark owned and maintained by the Assignor:  
U.S. Trademark: BIO-PURE, Trademark Registration No.2353230, Trademark Registration dated May 30th 2000

### Article 2. Assignment of Trademark


As of the effective date of this Agreement the Assignor assigns and transfers all rights and interest to the Assignee for the MARK.

### Article 3. Trademark Changing Procedure

The Assignor shall within 7 months of the effective date of this Agreement take all necessary procedures to assign and change the owner's name of the MARK from the Assignor to the Assignee at the United States Patent and Trademark Office.

### Article 4. Assignment

The rights and obligations pursuant to this Agreement are not transferable to any third party by agreement, operation of law or otherwise and any purported transfer of said




MARK shall be void and a breach of this Agreement.


Article 4. Entire Agreement
