## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement") is made and entered into as of October 7, 2016 (the "Effective Date") by Oxford Immunotec, Inc., a Delaware corporation with an address of 700 Nickerson Road, Suite 200, Marlborough, Massachusetts 01752, United States (the "Assignor"), and Oxford Immunotec Limited, a United Kingdom limited company with an address of 94C Innovation Drive, Milton Park, Abingdon, Oxfordshire, OX14 4RZ, United Kingdom (the "Assignee") (each a "Party," and collectively the "Parties").

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the trademark identified on Schedule A attached hereto ("Mark") together with the goodwill of the business associated therewith.

WHEREAS, Assignee is desirous of acquiring all right, title and interest in and to the Mark together with the goodwill of the business associated therewith.


NOW, THEREFORE, in consideration of the mutual promises and covenants hereinafter set forth, the sufficiency for which are hereby acknowledged by both Parties, the undersigned Parties intending to be legally bound agree as follows:


1. The preamble shall form part of this Agreement and the representations and warranties of the Parties.
2. Assignment. Assignor hereby sells, assigns, transfers and sets all right, title and interest in and to the Mark over to Assignee, its successors and assigns, including any renewals and extensions of the registrations that are or may be secured, now or hereafter in effect, together with the business and goodwill of the business in connection with which the aforesaid Mark has been used, and including (a) all income, royalties and rights to payment with respect to the Mark, and (b) all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark with the right to sue for, and collect the same for the Assignee's own use and enjoyment.
3. Assignor shall do all acts and execute all documents which may be reasonably required by Assignee in order to effect the assignment of the Mark.
