**EXECUTION VERSION**

**RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT**

**THIS RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT** (this "Release") is made as of November 18, 2016 (the "Effective Date") by DEUTSCHE BANK AG NEW YORK BRANCH, as collateral agent (in such capacity, together with its successors and assigns, the "Collateral Agent"), in favor of CHROMAFLO TECHNOLOGIES CORPORATION, an Ohio corporation ("Chromaflo"), and CPS COLOR GROUP OY, a limited liability company organized under the laws of Finland ("CPS" and together with Chromaflo, the "Pledgors").

**WHEREAS**, pursuant to the terms and conditions of that certain Second Lien U.S. Guarantee and Collateral Agreement dated as of December 2, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time), between the Collateral Agent, Chromaflo and the other grantors party thereto, Chromaflo entered into the Second Lien Trademark Security Agreement with the Collateral Agent, dated as of December 2, 2013 (the "Chromaflo Trademark Security Agreement");

**WHEREAS**, pursuant to the terms and conditions of that certain First Lien/Second Lien Floating Charge Pledge Agreement dated as of December 2, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time), between the Collateral Agent and CPS, CPS entered into the Second Lien Trademark Security Agreement with the Collateral Agent, dated as of January 31, 2014 (the "CPS Trademark Security Agreement" and, together with the Chromaflo Trademark Security Agreement, the "Trademark Security Agreements");

**WHEREAS**, pursuant to the terms and conditions of each Trademark Security Agreement, each of the Pledgors pledged, assigned and granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to certain Pledged Collateral (each as further described in each of the Trademark Security Agreements), including, without limitation, the trademark registrations and applications and domain names set forth on Schedule I hereto, along with the goodwill associated therewith (collectively, the "Trademark Collateral");

**WHEREAS**, the Chromaflo Trademark Security Agreement was recorded with the Trademark Division of United States Patent and Trademark Office on December 4, 2013, at Reel 5176 and Frame 0831;

**WHEREAS**, the CPS Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on February 4, 2014, at Reel 5207 and Frame 0922;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby, without any warranty or recourse of any kind, terminates each of the Trademark Security Agreements, and hereby terminates, cancels, and releases any and all pledges, grants, assignments, liens or security interests in the Trademark Collateral, including without limitation, the trademarks registrations and applications and domain names set forth on Schedule I hereto.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademark Collateral, it hereby re-assigns and re-transfers such rights, title or interest to their respective Pledgors.

The Collateral Agent shall take all further actions, and provide to the Pledgors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors, at the Pledgors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
