## RELEASE OF SECURITY INTEREST IN TRADEMARKS

**WHEREAS**, DIGITAL SANDBOX, INC., a Delaware corporation (the “Company”) entered into that certain Revolving Credit, Term Loan and Security Agreement (as amended, amended and restated, restated, supplemented modified or otherwise in effect from time to time the “Loan and Security Agreement”), dated as of July 30, 2014, with PNC BANK, NATIONAL ASSOCIATION (the “Secured Party”), and the other parties thereto. Capitalized terms used herein but otherwise not defined herein shall have the meanings ascribed to them in the Loan and Security Agreement; and

**WHEREAS**, pursuant to the Loan and Security Agreement, the Company executed and delivered to the Secured Party that certain Intellectual Property Security Agreement, dated as of July 30, 2014 (as amended, amended and restated, restated, supplemented modified or otherwise in effect from time to time the “Grant”), which Grant was recorded with the United States Patent and Trademark Office on August 4, 2014 at Reel 5335, Frame 0858; and


**WHEREAS**, pursuant to the Grant and the Loan and Security Agreement, the Company granted to the Secured Party a security interest in the Company’s trademarks and trademark licenses, including, without limitation, the trademarks identified on Schedule A attached hereto.

**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party, without representation, warranty or recourse, hereby terminates and releases its security interest in the trademarks and trademark licenses owned by the Company (and specifically excluding those owned by NetCentrics Corporation, a Virginia corporation), including, without limitation, the trademarks identified on Schedule A attached hereto, effective as of the date set forth above.

The Secured Party acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.
