**PARTIAL RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

This **PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (the "Release") dated as of October 31, 2016, is granted by Credit Suisse AG, Cayman Islands Branch, as Collateral Agent (the "Collateral Agent") to Emerald Hilton Davis, LLC, Emerald Carolina Chemical, LLC, and Emerald Foam Control, LLC (each a "Grantor" and collectively the "Grantors"). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Credit Agreement or the Security Agreement, referred to below, as applicable.

WITNESSETH

WHEREAS, Emerald Performance Materials, LLC (the "Borrower"), the Lenders party thereto and Credit Suisse AG, Cayman Islands Branch, as Collateral Agent and Administrative Agent, entered into that certain First Lien Credit Agreement dated as of August 1, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Borrower, the Guarantors party thereto and the Collateral Agent entered into that certain First Lien Security Agreement dated as of August 1, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") and certain other Security Documents;

WHEREAS, pursuant to the Credit Agreement and the Security Agreement, the Grantors executed and delivered to the Administrative Agent that certain (i) First Lien Patent Security Agreement dated as of August 1, 2014 (the "Patent Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on August 5, 2014 at Reel/Frame Nos. 33472/0465 and 33472/0781, and (ii) First Lien Trademark Security Agreement dated as of August 1, 2014 (the "Trademark Security Agreement") and recorded with the USPTO on August 5, 2014 at Reel/Frame Nos. 5336/0974, 5336/0933, and 5337/0239, pursuant to which the Grantors granted to the Collateral Agent for the benefit of the Secured Parties a continuing security interest (the "Security Interest") in their right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement) and the Trademark Collateral (as defined in the Trademark Security Agreement) (collectively the "Intellectual Property Collateral");

WHEREAS, the Collateral Agent has agreed to release its Security Interest in all of its right, title and interest in, to and under the patents, patent applications, trademark registrations, and trademark applications set forth in Schedule I, attached hereto and incorporated herein by this reference (the "Released Collateral"), and to reconvey any and all of its right, title, and interest in and to the Released Collateral to the Grantors; and

WHEREAS, the Security Interest in the remaining Intellectual Property Collateral granted to the Collateral Agent pursuant to the Patent Security Agreement and the Trademark Security Agreement (the "Remaining Collateral") will be unaffected by this Release and such Security Interest will continue in full force and effect.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all of its right, title and interest in, to and under the Released Collateral. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Released Collateral under the Credit Agreement and the Security Agreement.
