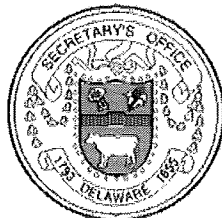

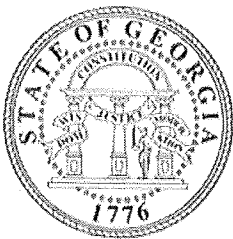

1. The name of the company to be converted is Apex Software Technologies, Inc., a Georgia corporation.

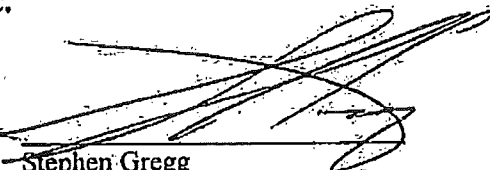
4. The plan of conversion has been approved, as required by O.C.G.A. §14-2-1109.3.
