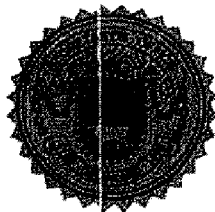

Fifth: The name of the surviving foreign Limited Liability Company is Springer Science and Business Media, LLC.


